2025 E-LEARNING AGREEMENT

The following agreement covers the student's use of all e-Learning facilities at Gisborne Intermediate School for educational use and the online publication of student work and images. *Students may use these facilities for class work, research, the preparation of assignments and appropriate school communication.* The resources provided include computers, access to network resources, educational programmes and the internet. Care must be taken to ensure the resources are protected from harm and that no users are exposed to materials considered offensive or illegal. Students and parents should carefully read the conditions below. To have access to the school's e-Learning resources, students must agree to abide by the school's e-Learning Agreement.

- 1. I will be given my own Google Account username and I will log on only with that username. I will not allow anyone else to use my username, or give anybody else access to my account.
- 2. My password is my own for which I am responsible.
- 3. I will not use or have any involvement in using my school account in a way that might put myself or anyone else at risk (e.g. bullying, endangering my Cyber Safety, inappropriate use...).
- 4. I understand that at all times ICT must not be used to offend, upset, or bully under any circumstances.
- 5. I understand that the rules in this agreement apply to BYOD devices as well.
- 6. Students must take care of and care for all ICT tools and equipment at all times.
- 7. Students' online school accounts will be monitored. Students need to be aware that documents, files, and media stored in their Google Drive folders will be checked from time to time by their teacher or the computer technician. Any students not following instructions will have access restricted or denied.
- 8. The use of e-Learning facilities, specifically the Internet, is for educational, collaboration, and research purposes only:
 - Deliberate attempts to look for or download and use material that is illegal or which would be thought of as offensive is not permitted. Only materials required for **school activities** may be downloaded. If students should unknowingly navigate to a website that contains material that may be considered offensive, they must clear the screen immediately and notify the teacher.
 - Privacy and ownership of others' work and materials from the internet must be respected at all times. Teachers will endeavour to educate students around the understandings of copyright and creative commons.
 - The use of online collaboration through chat facilities, video conferencing etc, must only be carried out as part of educational online activities.
- 9. When bringing a BYOD (Bring your own device) to school students and parents understand:
 - Students will need their BYOD named to identify the owner.
 - Students take full ownership for their device; including insurance. School will not replace damaged or lost equipment.
 - All devices must arrive at school each day fully charged. A charger may be used during the day if required.
 - Devices are only to be used under adult supervision. Not during interval or lunch times without teacher permission.
 - Devices brought to school are for the use of my child. Any sharing is at my child's discretion.
 - Students will use cloud based applications such as Google Apps for file management.
 - To ensure appropriate network filters, students will only use the BYOD wireless connection in school and will not attempt to bypass the network restrictions by using outside networks such as 3G/4G.
 - It is the owner's responsibility for the repair of any malfunctioning/damaged devices. Gisborne Intermediate does not supply technical services for student owned devices.

Online Publication of Student Images and School Work

The school uses a range of learning technologies to enhance student learning. These include email, and the Internet. From time to time, we publish on the school's website and social media sites (such as Facebook); material for educational purposes, to share the results of learning within the school community, and to promote the school within the wider community. This may include examples of students' schoolwork and images of students and groups of students in activities at the school. Images of students may include scanned, digital, or video of them taking part in school or class activities.

Kia ora koutou,

This information is for those families who **live outside our school enrolment zone** and are looking at enrolling **a new Year 7 student** to our school.

This enrolment scheme only impacts **NEW** enrolments.

If you live out of zone and your child **already attends** Gisborne Intermediate, your child can still attend Gisborne Intermediate. They will automatically move to Year 8. You **do not** have to apply for a place. If you have a new Year 7 child who will be enrolling, you will need to follow the process below.

2025 enrolments

On direction from the Ministry of Education, we need to reduce our overall numbers in the school. The Board of Trustees has met and discussed the number of students we are likely to be receiving from our contributing schools and how many places we can offer to out-of-zone students.

For 2025, the board has decided that we can offer <u>40 places</u> for out-of-zone students who will be Year 7 in 2025.

Placements are **NOT** offered on a first-in-first-served process. These are allocated through the criteria in the attached documents.

Timeline (the Ministry of Education sets the closing date and date for offering placements)

Monday 19th August 2024 – all enrolment applications welcome.

Monday 21st October 2024 - 3.30 pm - enrolments for out-of-zone places close.

To be considered for an out-of-zone placement, your enrolment form needs to be completed and with the office by this time.

Friday 1st November 2024 – Out-of-zone placements offered.

You will be contacted about your application for an out-of-zone place no later than Monday 1st November 2024.

Application forms will be available on our website www.gisint.school.nz, for collection from the office, or contact the office and they will email one to you. These are available from Monday 19thAugust 2024.

Please find attached the information on our home zone and the criteria for processing out-of-zone applications.

Out of zone enrolments

Each year the board will determine a number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone.

For 2025, the board has decided that we can offer 40 places for out-of-zone students who will be Year 7 in 2025.

Applications for enrolment will be processed in the following order of priority.

These priorities are set by the Ministry of Education, not by Gisborne Intermediate.

First Priority

This priority category is not applicable at this school because the school does not run a special programme approved by the Secretary.

Second Priority

Must be given to any applicant who is the sibling of a current student of the school.

Third Priority

Must be given to any student who is the sibling of a former student of the school.

Fourth Priority

Must be given to any applicant who is a child of a former student of the school.


Fifth Priority

Must be given to any applicant who is either a child of an employee of the board of the school, or a child of a member of the board of the school.

Sixth Priority

Must be given to all other applicants.

Places must be allocated in priority order until each category is reached. If there are more applications than places available, selection will be made by ballot.



Home zone

All students who live within the home zone described below (and shown on the attached map) shall be entitled to enrol at the school.

Home zone description

From the Wainui Rd Bridge the zone boundary travels along the western side of the Waimata River up to and including 299 Riverside Road.

The boundary then travels in a northwesterly direction around the outskirts of Gisborne City including those roads with direct access to Valley Road and Shelley Road.


The home zone boundary then travels in a northerly direction to 1813 Waimata Valley Road including Mander Road, Utting Road, Bailie Road, Monck Road and Marshall Road.

It then travels overland in a westerly direction including Ngakoroa Road and Newman Road, crossing Matawai Rd (SH2) to McMillan Road.

The boundary travels south including Humphreys Road and Lavenham Road up to the intersection with Tangihanga Road, until it reaches Waipaoa River.

The home zone boundary then follows the Waipaoa River to the coast. The boundary then travels north along the coast to the Wainui Rd Bridge.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a community newspaper circulating in the area served by the school. This will enable



the board to assess the number of places which can be made available to students who live outside the home zone.
